Sequel to the approval of the Chairman to the resolutions passed by the State Affiliation Committee in its meeting held on 29-08-2018 at Civil Secretariat Srinagar , sanction is hereby accorded to the:-

1. Grant of extension in the period of affiliation in favour of **65(Sixty Five) Private Educational High/Higher Secondary institutions of Kashmir Division** for a period of five(05) years from the Academic Session Oct- Nov. 2018 to Oct-Nov 2023 forming Annexure "A" to this order.
2. Grant of up-gradation in favour of **09 (Nine) Educational Institutions of Kashmir Division up to High/Higher Secondary Level for a period of Five years** from the Academic Session **Oct- Nov. 2017 to Oct-Nov-2022** (in respect of Sr. No.01 to 03, 05 to 08 and S.N 10=08) and from Academic Session **Oct- Nov 2018 to Oct-Nov- 2023** (in respect of sr. no. 04) forming Annexure "B" to this order.
3. Grant of Extension(9th and 10th) /Upgradation (class 11th to 12th) in favour of **Abinandan Home Modern High School Solina (Deaf and Dumb School) from the Academic Session 2018 to 2023** reflected at serial no.09 of Annexure "B".

The affiliation shall strictly be governed by the terms and conditions as laid down vide SRO 123 read with SRO-292, relevant Govt. orders, BOSE regulations and the resolutions of the State Affiliation Committee meetings passed from time to time.

- A. That the minor deficiencies like introduction of C.P fund, disbursement of salary through banks, improvement of library/laboratory and other minor deficiencies reflected in the said annexure against each institution are to be addressed within a time bound period of three months and the institutions are required to submit the compliance report to Board office within three months otherwise their affiliation shall liable to be cancelled.
- B. There shall be no compromise with safety conditions, therefore three mandatory Statutory Certificates viz Building safety, Fire Safety, and Chemical Safety by the designated authorities are essential for the consideration of the affiliation and the institutions concerned shall be required to submit renewed certificates immediately after expiry of the validity period of said Safety certificates besides the compliance to NBC (National building code) norms are to be ensured .
- C. It shall be binding upon all the Institutions to fulfill all the statutory conditions laid down from time to time.
- D. The financial transactions including the payment of salary to the Staff is to be made through Bank.
- E. All the private Educational Institutions shall adhere to the fee structure fixed by the Fee fixation Committee of the Govt. failing which they are liable to be disaffiliated.
- F. All schools have to adhere to the conditions imposed by the Competent authorities for safe transportation of students.

- G. The heads of the affiliated Institutions shall keep their infrastructure like the Examination hall and related facilities at the disposal of the BOSE as and when needed and especially at the time of the examinations.
- H. The Academic calendar prepared by the BOSE is to be strictly adhered to. Any deviation thereof will invite imposition of penalty.
- I. It will be obligatory to stick strictly to the curriculum adopted by the BOSE for all classes and prescribe Books published by the JKBOSE for transaction of the Curriculum and the proper arrangement for co-curricular and extra-curricular activities for the students must be ensured.
- J. To maintain hygiene and sanitation, ensure separate Toilet facilities for both boys and girls. An additional facility of Change room is to be made available to the female staff/students. The First aid facilities are also to be ensured.
- K. Parent Association as required under Norms has to be there along with Managing committee to ensure the Academic development.
- L. The EPF/CPF (whichever is applicable) is to be maintained with the required contribution towards the fund.
- M. It shall be obligatory upon all the affiliated academic Institutions to obtain recognition Order from School Education Department.
- N. The previous period of provisional affiliation is regularized in respect of the extension cases with a token fine of Rs2000/- for each year of their period of provisional affiliation.
- O. All the institutions shall make it convenient that the heating and cooling arrangements are in place.
- P. All the Institutions shall ensure the renewal of all certificates as are envisaged in SRO-292 dated:-2nd July 2018.
- Q. All the Institutions are put on strict instructions to ensure the submission of their renewal case file in the office of the undersigned before one year of expiry of period of BoSE affiliation i.e latest by 31st December of the year prior to the year of BoSE Affiliation. Otherwise the late fee as per Bose norms is chargeable.
- R. There will be a periodic Inspection of the Institutions to ensure that the conditions put forth are complied with.

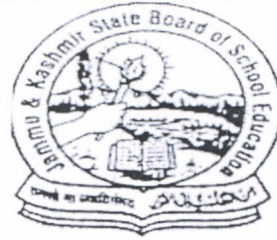
The compliance to the above mentioned requirements is obligatory and any deviation thereof will invite penalty, even de-affiliation from JK BOSE.
