• Reappear/ Failure candidates of HSP-I(Class 11th) Annual/Regular, 2020 Examination

 Subject Change, Improvement of performance / Additional subjects of Annual/Regular, 2020

Besides above, candidates of Higher Secondary Part-II (Class 12th) studying in the Affiliated Academic Institutions of the Kashmir Division and those candidates who have or are intending to migrate to J&K BOSE from other Recognized Boards in Class 12th, for the current Academic Session 2020-21, and are desirous to change their subject/s, as per the combination of subjects/ scheme of studies, shall be allowed to do so after completion of required formalities/ deposition of the requisite fee of Rs.350/- and submit the PCA Forms of the corresponding changed subject/s in HSP-I (Class 11th) on normal prescribed fee, till 9th June, 2021.

Notwithstanding the result for HSP (Class 12th) Annual/Regular, 2021 shall be kept withheld under Disputed Eligibility category till they qualify the corresponding changed subject/s in HSP-I (Class 11th).

Further, the candidates of SSE (Class 10th)Annual (Private)/ Bi-Annual,2019-20, who have been declared successful under Re-evaluation notification dated.25-03-2021 and are eligible to submit the PCA Forms for HSP-I (Class 11th) Annual (Private)/ Bi-Annual,2020-2021 Examination shall also be allowed to do so on deposition of normal prescribed fee for PCA Forms and Renewal Registration Returns, till 9th June,2021.

Note: <u>Dates notified are inclusive and no preparation days are allowed.</u>
General Instructions:

• The Permission-Cum-Admission Forms shall be available in the concerned Divisional/ District/Tehsil Offices of the BOSE and shall be issued to the Authorized representative/ Admission In-Charge of the Affiliated Academic Institution against payment of Rs. 20/- as cost of PCA Form.

The candidates are directed to check their registered particulars and affix one latest digital coloured photograph on their respective Permission-Cum-Admission Forms and submit the same in their respective Institutions.

The dealing assistants of the District/ Tehsil Offices of the BOSE shall be under ogligation to ensure that the PCA Forms are scrutinized well in advance before the commencement of the examination or before issuing of the Admit Cards, which

ever is earlier, to avert any unforeseen ill occurrences.

Instructions for Heads of the Affiliated Academic Institutions: The Heads of the Institutions are instructed to:

Furnish an undertaking and ensure that:

a. no proxy or any fake attestation is executed from their Institution and shall keep information regarding the candidates appearing through their respective schools by reference of the school sent-up readily available.

b. Registered Particulars of five candidates only on each side of the Enrollment sheet.

- The eligibility certificates shall be enclosed with the respective PCA Forms of each candidate.
- Cell numbers of each candidate shall be necessarily recorded on the enrollment
- Affix latest digital coloured photograph of each candidate against his/her particulars on the Statement of Enrollment duly signed and stamped, as well as on the sent-up list which remains with the Institution for record and reference.
- Cover the photographs with quality transparent adhesive tape on the Statement of Enrollment to avoid chances of misuse and impersonation.
- To deposit the prescribed fee, of their eligible candidates, in the designated Branches of the J&K Bank Ltd., in the shape of "Bank-Slip" to be obtained from the concerned Divisional/ District/Tehsil Offices of the BOSE.
- Submit the Permission-cum-Admission Forms and Statements of Enrollment/ Renewal Registration Return sent-up wherever applicable, complete in all respects & duly filled in on the prescribed formats along with forwarding letters, in triplicate, in the concerned Divisional/District/Tehsil Offices of the BOSE through their Authorized representative/ Admission In-Charge only. The letters must indicate the number of candidates (enrolled & appearing) subject wise and description of fee deposited in the Bank. Subject-wise micro-pack be also indicated below on each page of the Statement of Enrollment.

Note:- In case the last date/s for submission of returns/ fee is declared as holiday, the next working

day shall be treated as the last date.
